

#### **Purposes of the Declaration**

- Global "wish list" on parliamentary transparency
- Vehicle for shared action by the majority of the world's PMOs
- Tool for advocacy at global level
- Framework for organizing comparative information on parliamentary openness:
  - A wiki of good practice
  - Possible PMO-sourced country rankings
